1. Call Select Board meeting to order: Chris Plumb called the meeting to order at 6:30 p.m.

#### 5. New Business:

- **B.** Open Meeting Law legislation Susan suggested asking for an exemption for smaller municipalities like Andover. All members agreed they are against the legislation because it would require all public meetings to be hybrid meaning purchasing equipment, among other things. Chris will be testifying via Zoom on the 13<sup>th</sup> before the Senate Government Operations Committee & will share the Andover Board's disapproval of this proposed legislation.

## 6. Highways / Garage:

**A.** Road Commissioner's report – T16 (the 10-wheeler) has been in for repairs four times in the past month. Richard suggested having Charlie start gathering prices for a new truck. Chris also said the road crew likes the new loader.
